

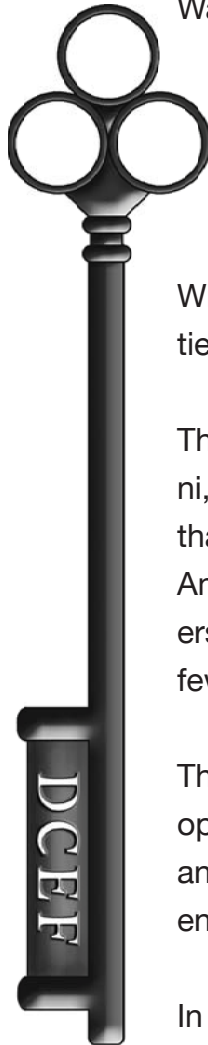

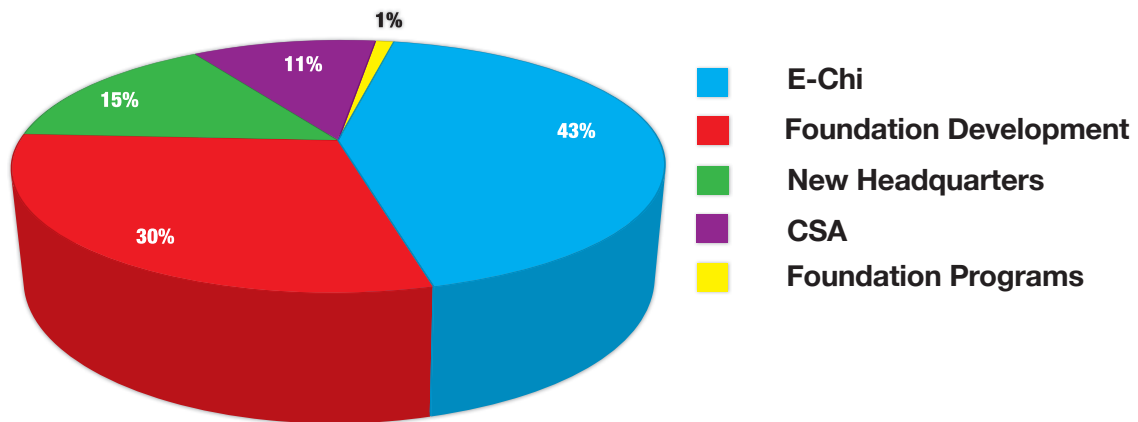
The Annual Fund Campaign provides support to our programs and operations. We cannot do it without your help and generosity. Join an annual giving society today and together we can make a difference.

2007 Foundation Gifts




The Delta Chi Educational Foundation receives gifts for various funds designated by the donor. These funds include:

- Gifts received by the Foundation that are earmarked for a specific Educational Chapter Housing Initiative (E-Chi) account have become a mutually beneficial method for providing tax deductible donor support to alumni boards and undergraduate chapters who are working on new housing and remodeling/renovation projects. Tax deductible donations to these accounts allows the Foundation to make one hundred percent distributions from these accounts back to a chapter or alumni board to support the educational needs of a Delta Chi Fraternity chapter. Gifts that are donated to these temporarily restricted accounts can also be used to support the annual expenses of a chapter house operation as predetermined by educational need.
- Annual gifts received by the Foundation Development Fund support the operation of the Foundation office and staff. Your generous contributions allow the Foundation office to provide the staff support and resources necessary for the operational and administrative duties of the Foundation.
- The Foundation has a new Foundation Headquarters account which is temporarily holding income for a new Foundation office.
- Scholarship gift income received supports various Chapter Scholarship Accounts (CSA) and Foundation Scholarship accounts. Permanently restricted donations to these accounts will allow the account to grow while providing annual income that can be used to provide educational and leadership scholarship awards. Anyone can set up a scholarship account benefiting the long term goal of the donor while providing Delta Chi's scholarships that will last perpetually. The Foundation awarded approximately \$34,000.00 in scholarships from these various accounts in 2007.
- Gifts to Foundation program accounts allow the Foundation to continue support of long standing programs.
